# Key Metrics

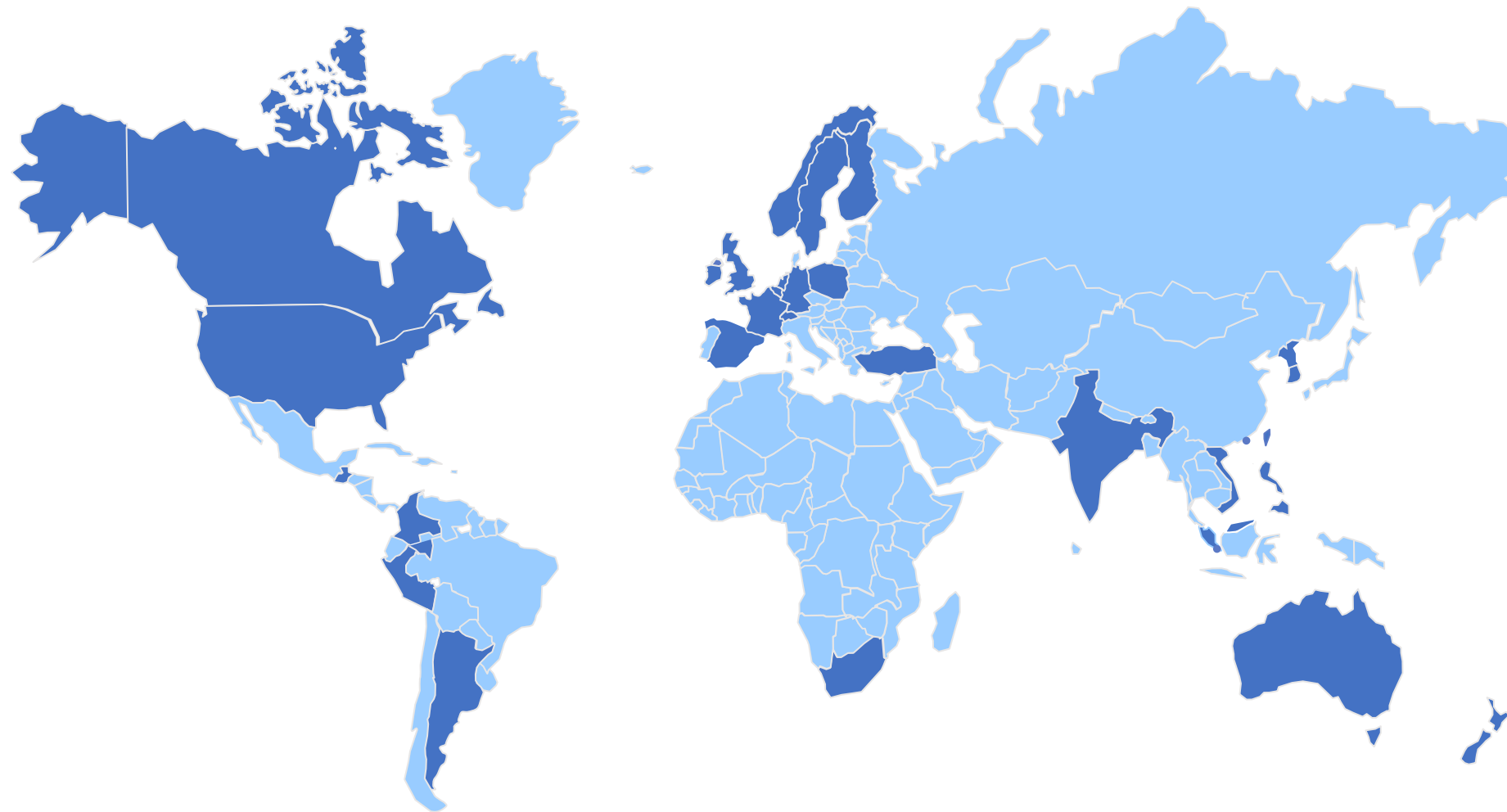
## Since February 2025

- In the last 12 months, 13,000 student manuals were downloaded in 107 countries, this being 54% of the 195 countries worldwide.

## Since February 2024

- 360 courses were conducted around the world
- 154 students passed (6) OHTA courses to qualify for the ICertOHTA qualification
- 13 ICertOHTA awardees went on to pursue the new OHTA pathway to the Certified Industrial Hygienist (CIH) credential
- New Specialist course on the Mining and Mineral Processing Industries was released.
- 9 course manuals and training materials were translated into Spanish.

# Innovation to meet Global Demand

## OHTA Growing IH/OH Capacity

- Courses are now offered On-line, Classroom & Hybrid with a mix of on-line training and face to face for practical exercises.
- OHTA courses are now offered in new countries where limited IH/OH training was available and in local languages. Countries include as Senegal and Francophone Africa, Nigeria, Angola, Iraq, Saudi Arabia, Turkey, Fiji and China.
- Students include site IH/OHs technicians, HSE Managers, government inspectors and regulators, occupational health doctors and nurses as well as engineers.

**A total of 1100 exams were completed by 3Q25 with many students on the pathway to a ICertOHTA.**

# Technology Led Changes to Exams

## Advanced LMS Platform

- MCQ exams introduced in 2024, based on an LMS system used globally by universities.
- Exam results and OHTA certificates now available within 24 hours for Trainers to send to students.

## Global Reach through Translations

- New **Artificial Intelligence** (AI) technology allows the OHTA MCQ exams to be translated to multiple languages. Currently using exams in French, Spanish, Turkish and Indonesian.

# New courses for 2025 and 2026



## OHTA 1001 Mining & Mineral Processing Industries

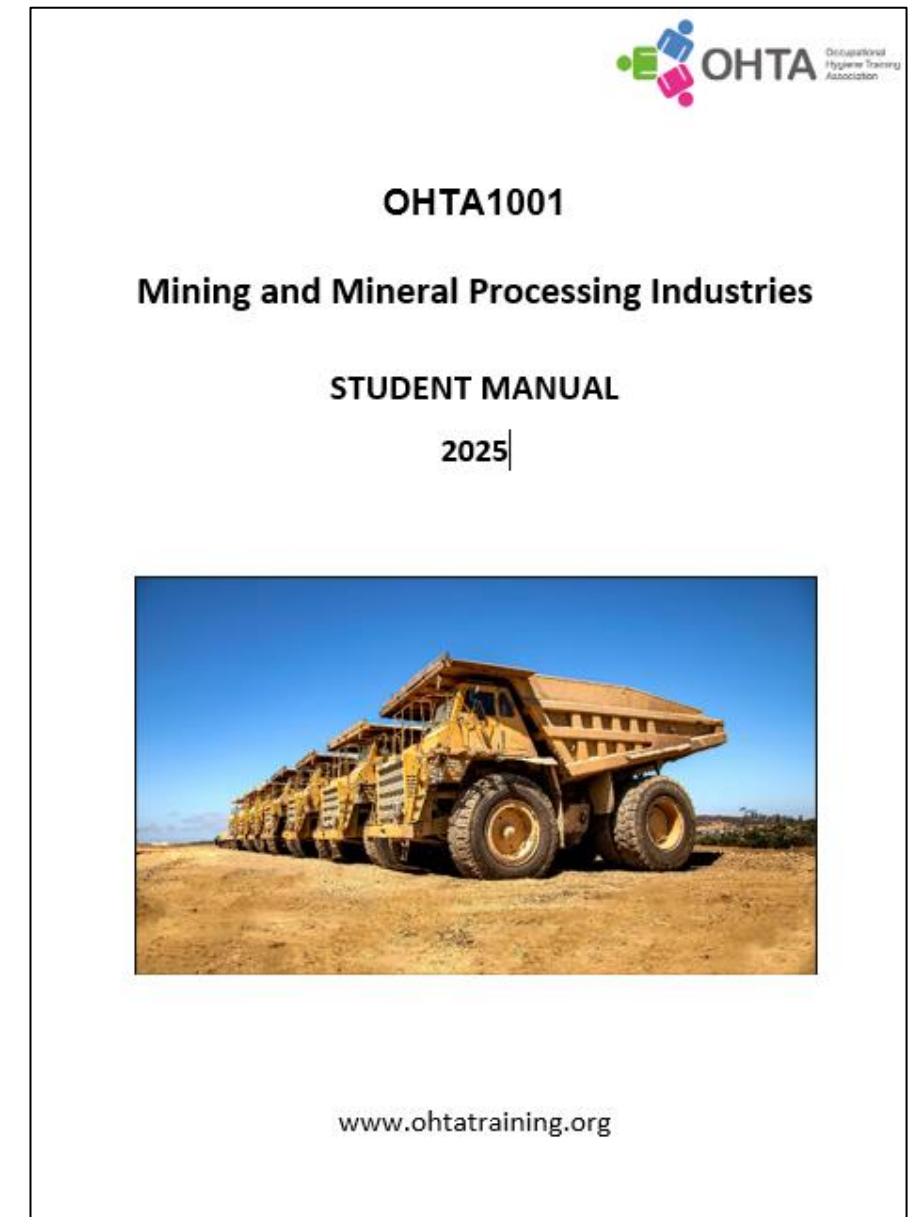
This course is now available and designed for people working at mine sites such as IH/OH technicians, medical and emergency staff, HSE & contractors. It gives a practical overview of IH/OH hazards and risks in the mining resource industry.

MCQ exam is available and can be translated.

## OHTA 1003 – OHTA1003–Pharmaceutical Industry

This course is designed for contractors and supply companies. It is planned to be available 1Q26.

MCQ exam will be available and can be translated.



# ICertOHTA Qualification



## Pathway to Professional Recognition

The ICertOHTA has become the preferred technician training certificate with 150 successful students globally starting their career.

The ICertOHTA is achieved after successful completion of 6 OHTA courses and there are no fees for the Certificate

## Gateway to Advanced Credentials

The ICertOHTA and OHTA training modules also count toward the IH/OH coursework requirement for the **CIH credential** awarded by the Board for Global EHS Credentialing.

They also contribute to **other credentials** offered by national IOHA NAR recognized accreditation schemes.

# OHTA Supporting Careers in IH/OH



## 1. Certified Industrial Hygienist (CIH)

In 2024, OHTA announced a new partnership with AIHA ([aiha.org](http://aiha.org)), Workplace Health Without Borders-US ([whwb-usa.org](http://whwb-usa.org)), and the Board for Global Credentialing ([gobgc.org](http://gobgc.org)).

This partnership aims to **help qualified applicants in emerging economies** achieve the prestigious CIH credential.



## 2. Emerging Economies

OHTA sponsors and supporters enable OHTA consider adjustment to exam fees to support countries where students cannot afford to pay the standard fee, \$125 USD/£100.



3. **OHTA also supports IOHA national associations** to become Approved Trainers to build national capacity and expertise.

# OHTA Communications to Sponsors

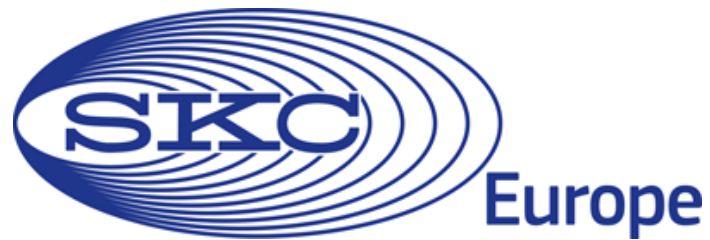
- OHTA uses social media and personal contact to gain corporate sponsors and individual supporters.
